# SWEEPSTAKES PROGRAM SURPASSES \$7 MILLION

What started 10 years ago as a way to help needy Catholic schools has blossomed into a program that has put more than \$7 million in the coffers of the schools.

"Every week, I would open a letter or get a call from another Catholic school in need," said President J. Michael Belz. "We wanted to help them all, but their needs were great and our funds were limited. We put our heads together and the solution we came up with was the Catholic Schools Sweepstakes."

Since its beginning 10 years ago, 84 schools from 13 Texas dioceses have taken part in the program. In total, the program has raised more than \$7 million dollars.

"Participating schools are only limited by the amount of money they can raise, instead of what we can give them," he said. "The top school this year raised more than \$50,000. In other years, that amount has exceeded \$75,000."

Catholic Life provides the prizes, the tickets and marketing materials while students at participating schools sell tickets at \$5 each. The ticket sales begin in the fall and close during Catholic Schools week held the last week of January. In 2017, 59 Catholic Schools from 11 Texas dioceses sold 190,594 tickets to raise \$952,970.

"The schools get 100% of the funds and they get the money as the tickets are being sold," said President Belz. "This lets the school put the money to work right away. Catholic Life earns no money from this program. We do it to support Catholic education."

Sixty winners were drawn on Saturday, January14th at the Home Office in San Antonio. Justin Gamez of Corpus Christi, whose son is a student at Our Lady of Perpetual Help Academy in Corpus, was the grand prize winner. He had the choice of a 2017 Ford F150, a 2017 Ford Fusion or a \$20,000 Prepaid VISA Credit Card as a prize. He selected the \$20,000 Prepaid VISA Credit Card as a prize.

Additionally, each of the 59 participating schools had a \$1,000 Prepaid VISA Credit Card winner drawn from the tickets that they sold.

The schools are very grateful for the program," said program administrator Barbara Cheaney. "They use the funds for a variety of programs, but mostly to enhance operations and to provide tuition assistance."

Our Agents play a key role in the program. They pick up tickets from the schools, provide additional prizes and educate the schools about Catholic Life Insurance.

"We are extremely pleased with the results of the Sweepstakes. Our goals are to grow the number of schools who participate and the amount of money being raised," added Belz. "It is the right thing for Catholic Life to be doing, particularly in today's economy."

# IRS REPORTING DISTRIBUTED ON "NEW" SUBSTITUTE 5498 TAX FORM

You may receive the Substitute IRS Form 5498 in the mail from us, in late May or early June of this year. Don't be alarmed. The IRS requires that we mail this notification to members who have a Traditional IRA, Traditional Conduit IRA, SEP-IRA, Roth IRA, or a Roth Conversion IRA and you have made 2016 contributions.

The substitute tax form reports to the IRS the following:

- ▶ All 2016 **individual** tax year contributions deposited into Traditional IRAs and Roth IRAs during the 2016 tax year, and from January 1, 2016 through April 18, 2017
- ► Employer SEP contributions made between January 1 and December 31, 2016
- ► Employer retirement money rolled over into Traditional IRAs and Traditional Conduit IRAs between January 1 and December 31, 2016
- ▶ Rollover contributions into any type of IRA made between January 1 and December 31, 2016
- ▶ Roth conversions made between January 1 and December 31, 2016
- ▶ The Fair Market Value as of December 31, 2016
- ▶ If you are required to take an IRS required minimum distribution during 2017, this is indicated on the form

You are not required to file Form 5498 with your 2016 tax return. However, if you have reported any contributions, rollovers or conversions on your 2016 1040 income tax return, they must agree with Form 5498. Additionally, Employer SEP contributions deposited during the 2016 tax year must agree with the amount on the form.

We ask that your review this document carefully as all corrections to the form must be made, **in writing** by June 28, 2017. Unfortunately, we are unable to make any corrections after July 1, 2017.

# IRA SEASON IS HERE!

If you are one of the millions of Americans who own an IRA, now is a great time to review your retirement savings strategies. One of the best strategies is opening or adding to a Catholic Life IRA.

You have until April 18, 2017 to open

or add to an IRA and still receive credit for the 2016 tax year. For 2016 and 2017 tax year returns the maximum contribution you can make is \$5,500 or 100% of your income if it is less than \$5,500. If you are over age 50, you can contribute up to \$6,500 or 100% of your income if it is less than \$6,500.

# **Traditional vs. Roth**

There are two basic types of IRAs: Traditional and Roth. Contributions to Traditional IRAs are fully tax deductible if you are not an active participant in a pension or profit sharing plan where you work. If you take part in a retirement plan at work, you can still contribute to a Traditional IRA; however, your adjusted gross income could limit the amount you can deduct. Deductions phase out if your adjusted gross income is between \$98,000 and \$118,000 for a couple filing jointly or between \$61,000 and \$71,000 for a single head of household.

You *may not* contribute to a Traditional IRA once you have attained age 70½, even if you are still working. If you own a Traditional IRA, you must take required minimum distributions once you reach 70½. The IRS considers any distributions from a Traditional IRA as ordinary income and taxes them as such.

If you want income tax free distributions, a Roth IRA may be of interest to you. The money you contribute to a Roth IRA does not qualify for a tax deduction, however; when you take the money out later, it is not subject to income tax. If certain conditions are met, you can also take out the earnings in your Roth IRA tax free. The contribution limits and deadlines are the same as a Traditional IRA

Contributions to a Roth IRA are subject to income qualifications. If you are a married wage earner filing jointly, you can have up to \$184,000 of income. However, contributions phase out for incomes between \$184,000 and \$194,000. For single tax filers, you may



contribute fully up to \$117,000. You phase out for incomes between \$117,000 and \$132,000 of income.

# Soy-Glazed Salmon with Spinach

4 Salmon steaks, ¾ inch thick (6 oz. each)

2 tbsp. seasoned rice vinegar

1 tbsp. grated, peeled fresh ginger

2 tsp. cornstarch

2 tsp. water

1/4 cup reduced-sodium soy sauce

1 garlic clove, crushed with garlic press

1 tbsp. dark brown sugar

1/8 tsp. crushed red pepper

1 (6 oz.) bag baby spinach

Preheat oven to 450 degrees. Place salmon steaks in 13x9 inch glass baking dish. Roast 5 minutes. Meanwhile, in a small bowl whisk soy sauce, vinegar, garlic, ginger, sugar, cornstarch, crushed red pepper and water until blended. Pour glaze over salmon. Roast about 5 minutes longer or until salmon flakes easily when tested with a fork and glaze thickens.

To serve, arrange spinach on plates. Top spinach with salmon and drizzle with remaining glaze.

# Parmesan-Baked Salmon

½ cup mayonnaise

2 tbsp. grated parmesan cheese

1/8 tsp. cayenne pepper

4 salmon fillets

2 tsp. lemon juice

10 Ritz crackers, crushed

Preheat oven to 400 degrees. Mix mayo, cheese, and pepper until well blended; set aside.

Place salmon on foil-lined shallow baking pan. Drizzle evenly with lemon juice. Top with cheese mixture; spread to evenly cover salmon. Sprinkle with cracker crumbs. Bake 12-15 minutes or until salmon flakes easily with fork.

# **Pecan-Crusted Salmon**

4 salmon fillets (6 oz. each)

2 cups milk

1 cup finely chopped pecans

½ cup all-purpose flour

¼ cup brown sugar

2 tsp. seasoned salt

2 tsp. black pepper

3 tbsp. vegetable oil

Place salmon fillets in a large resealable plastic bag; add milk. Let stand for 10 minutes. In a shallow bowl, combine the pecans, flour, brown sugar, seasoned salt and pepper. Coat fillets with pecan mixture, gently pressing into the fish.

In a large skillet, brown salmon in oil over medium-high heat. Transfer to a baking sheet. Bake at 400 degrees for 8-10 minutes or until fish flakes easily with a fork.

# Salmon with Herb-Almond Crust

2 (6 oz.) wild salmon fillets

3 tbsp. chopped almonds

2 tbsp. butter, softened

2 tbsp. fine dry bread crumbs (Panko)

1 tbsp. grated parmesan cheese

2 tsp. snipped fresh basil or parsley

½ tsp. finely shredded lemon peel

1 clove minced garlic

1/8 tsp. freshly ground black pepper

Rinse fish; pat dry. In a small bowl combine almonds, butter, bread crumbs, parmesan, basil, lemon peel, garlic, and black pepper. Place fish on the greased rack of a broiler pan. Spoon nut mixture on top of fillets; spread slightly. Bake fish in a 450 degree oven for 4 to 6 minutes per ½" thickness, or until fish flakes easily with a fork.


